Passholder Policies & Agreement

- Pass includes unlimited play on the Tunnel 9 (based on tee availability)
- Passholders receive a 50% discount off green fees (off full rate) on the Stanley Thompson 18
- Passholders receive 15% discount on regular priced merchandise (excluding hard goods) in the pro shop
- Passholders receive 15% discount on golf course food & beverage (clubhouse, snack bar & beverage cart)
- Passholder card must be presented at check-in and on-course to receive applicable discounts
- Passholder-guest privileges apply for up to a foursome (opening to June 4th: \$40.00, June 5th to close: \$50.00)
- Passholder-guests privileges do not apply on the Stanley Thompson 18
- A credit card must be provided to guarantee all passholder-guest bookings
- Tee times can be booked 7-days in advance
- If booking for multiple people all names must be provided to guarantee the reservation
- 24-hour cancellation policy (including all guest bookings)
